The issue of whether a certain contempt is civil or criminal can be of great importance. With a few notable exceptions, the Court has consistently distinguished between criminal and civil contempt, the former being a vindication of the authority of the courts and latter being the preservation and enforcement of the rights of the parties. Pennsylvania, U. United States defendants were sentenced by their respective District Courts to two years imprisonment for contempt of court, but the sentences contained a purge clause providing for the unconditional release of the contemnors upon agreeing to testify before a grand Issue of Contempt.

A written order on the court website said Rahul Gandhi was exempted from personal appearance. The Court then enunciated the principle that, where a fine or imprisonment imposed on the contemnor is designed to coerce him to do what he has refused to do, the proceeding is one for civil contempt.
